

**BLESSED HOPE COMMUNICATIONS  
FUND RAISING AGREEMENT**

1. This Agreement is between Blessed Hope Communications and \_\_\_\_\_, an independent agent who has chosen to market long distance service as an independent contractor of Blessed Hope Communications.
2. Blessed Hope is engaged in brokering long distance and other communications services to individuals and businesses in the 48 contiguous United States through several companies, including but not limited to Pioneer and Touchtone. Independent agent agrees to market these programs as an exclusive agent of Blessed Hope. Agent agrees that he will not make any attempt to circumvent these relationships in any way that would bring harm, damages, or financial losses to Blessed Hope.
3. Blessed Hope Inc. agrees to compensate independent agent on a commission basis only. Agent is paid a residual income commission (TouchTone) or one time commission (Pioneer) on all long distance accounts accepted and activated, and on revenue collected by the individual long distance carrier.
4. Independent agent must earn commissions of at least \$10.00 in order to receive a monthly check. Any monthly commissions over \$5.00, but less than \$10.00 will be carried forward to the next month. Commissions less than \$5.00 are not carried forward and do not qualify for a check. No checks will be issued that are less than \$10.00. Initial checks usually begin 90 days from the provisioning of the initial customer(s). Agent overrides are paid only if you qualify for a monthly commission check.
5. All expenses that agent may incur in connection with acquiring long distance customers are the responsibility of the independent agent. Blessed Hope will issue a 1099 tax statement for all agents who earn in excess of \$600.00 a year in income.
6. Blessed Hope may cancel this agreement at any time if independent agent is found to be guilty of "slamming" a customer's long distance service. The failure to acquire a customer signature upon a written application is a serious offense and may subject the individual agent to potential termination and possible civil penalties. Independent agent agrees to hold Blessed Hope harmless from any loss, cost, damage, expense or liability that occurs due to independent agent's violation of this clause in the agreement.
7. This agreement and all questions as to its interpretation, performance, enforcement and the rights and remedies of the concerned parties are governed by the laws of the State of Oklahoma and is binding on both parties. The parties agree that any legal action arising from this agreement and relationship shall be submitted to a Christian arbitrator in the state of Oklahoma.
8. This agreement will endure for a period of five years, subject to an automatic renewal.
9. Setup fee is waived for fundraising organizations.
10. All agent advertising must be pre-approved by Blessed Hope. Agent agrees not to interfere with Blessed Hope's current advertising efforts by competing in the same existing publications.
11. Agents will earn a commission of up to 14% on all long distance business written at 3.9 cents per minute in Touchtone (other rates and commissions vary). In Pioneer, agent earns a one time \$15 commission on each activated customer. Commissions on the 3.9-cent Pre-paid Calling Card are 12% (4.9 cards are 15%). Commissions on cell phone orders are a one time \$40 per order. Agents will receive copies of their commission reports as long as they meet the qualifications for a monthly commission check.
