

BLESSED HOPE COMMUNICATIONS INDEPENDENT AGENT AGREEMENT

1. This Agreement is between Blessed Hope Communications, and _____, an independent agent who has chosen to market long distance service as an independent contractor of Blessed Hope Communications (BHC).
2. BHC is engaged in brokering long distance and other telecommunication services to individuals and businesses in the 48 contiguous United States and Canada through several telecommunication companies and private agents. Independent agent agrees to market these programs as an exclusive agent of BHC. Agent agrees not to make any attempt to circumvent these relationships in any way that would bring harm, damages, or financial losses to BHC.
3. BHC agrees to compensate agent on a commission basis only. Agent is paid a commission on service accounts accepted and activated, and on revenue collected by the individual carrier(s) or provider.
4. Independent agent must earn commissions of at least \$10.00 (in each company) in order to receive a monthly check. Any monthly commissions over \$5.00, but less than \$10.00 will be carried forward for one month. Commissions less than \$5.00 (in each company) are not carried forward and do not qualify as earned income. No checks will be issued that are less than \$10.00. Initial checks usually begin 90-120 days from the provisioning of the initial customer(s). Any agent overrides will be paid only if the independent agent qualifies for a monthly long distance commission check.
5. All expenses that agent may incur in connection with acquiring customers are the responsibility of the independent agent. BHC will issue a 1099 tax statement for all agents who earn in excess of \$600.00 a year in income. Your investment in BHC is non-refundable.
6. BHC may cancel this agreement at any time if independent agent is found to be guilty of "slamming" a customer's long distance service. The failure to acquire a customer signature upon a written application is a serious offense and may subject the individual agent to potential termination and possible civil penalties. Independent agent agrees to hold BHC harmless from any loss, cost, damage, expense or liability that occurs due to independent agent's violation of this clause in the agreement.
7. This agreement and all questions as to its interpretation, performance, enforcement and the rights and remedies of the concerned parties are governed by the laws of the State of Oklahoma and is binding on both parties. The parties agree that any legal action arising from this agreement and relationship shall be submitted to a Christian arbitrator in the state of Oklahoma.
8. This agreement will endure for a period of five years, subject to an automatic renewal. Your residual income in BHC may be passed on to any family members or heirs that you may designate.
9. All print and media-related advertising or interviews must be pre-approved by BHC. Agent agrees not to interfere with Blessed Hope's current advertising efforts by competing in the same existing publications.
10. Commissions are determined individually and may change based on Blessed Hope's relationship with the agent and/or individual carriers. Generally, agents earn a one time \$15.00 commission on Pioneer long distance, plus have the potential to earn up to 5% residual commission when certain standards are met. Most cellular activations pay a one-time \$50.00 commission. Prepaid phone cards pay 12% - 15% on activations and recharges. Agent referral bonuses are \$25.00 on new paid agents. (some commission schedules may vary, see addendum for details if affected)
